<u>Ed Center Goals & Objectives for FY 2020:</u> The Pima District needs to partner with a not-for-profit to assist with education programs for conservation and agriculture. Materials from Ag in the Classroom (Arizona Farm Bureau) and Farm to Table (Arizona Dept of AG) could be used. These schools could be contacted: Sahuarita, Green Valley, Flowing Wells, Marana, and Amphi.
