Final Minutes of the Board of Supervisors of the Pima Natural Resources Conservation District (PNRCD)

Approve Feb 11, & March 11 Meeting Minutes: Supervisor DuHamel moved to accept the Feb 11 & March 11 meeting minutes. Supervisor Coping seconded. The motion carried 4-0.

AZ Game & Fish Heritage Fund Grant (Kyle Thompson, Biologist): The Winkelman NRCD was the first NRCD to have a district-wide grant (\$28,000) to clean/seal dirt tanks. Four ranches with a total of 8 dirt tanks were proposed in the WNRCD application. The 2020 application is due in August. So, Kyle would research (identify & document dirt tanks) and write-up the application, attend the August meeting to present the application to the committee, coordinate with the ranchers and Seepage Control Co. (ESS-13 Sealer) to apply the ESS-13, and manage the grant. Kyle's time would be billed at \$33/hour and it would cost about \$1,200 to write-up the grant application and attend the August presentation meeting. ESS-13 costs \$16,000/acre foot and the size of the dirt tank is about ½ acre. No money in the grant is available for administration and is only available on a reimbursement basis. Kyle suggested that Altar Valley should be contacted to see if they want to be a partner. Supervisor King said that Altar Valley assisted with a sealing demonstration but no projects were done. Supervisor Coping suggested that the cooperators should be surveyed. Supervisor Chilton suggested that a newsletter could be mailed to the cooperators. The Clerk will contact the Santa Cruz NRCD to see if they would be interested in partnering with Pima.

<u>Lovitt & Touche Dishonesty Bond:</u> Supervisor Coping moved to approve the bond for \$359. Supervisor King seconded. The motion carried 4-0.

<u>Invoices (Clerk & Supervisors):</u> Supervisor Coping submitted an invoice (\$164.35) for one night at the Holiday Inn during the AACD Winter Meeting. Supervisor DuHamel moved to approve the invoice for \$359. Supervisor King seconded. The motion carried 4-0.

**Meeting adjourned 1:40 pm.** Supervisor DuHamel moved to adjourn the meeting. Supervisor Coping seconded. Motion carried 4-0.
